We are incredibly proud that our unwavering focus on quality has led to us now delivering the largest number of services that Exceed the National Quality Standards. This is a testament to the capability and experience we bring to schools delivered by our extraordinary team of Educators.

We know that to continue to deliver these high-quality experiences takes a team of engaged and professional people. So, as we close out the school year our ongoing commitment to you and the Bacchus Marsh Primary School community is that we will continue to prioritise the coaching and development of our team to ensure that every program, every day supports the growth, wellbeing and development of every child.

We continue to ensure the cost of our OSH programs are accessible and affordable, but the general cost of living and wage rates have been increasing and the OSH sector has not been excluded from this. We have seen an increase in inflation by over 7%, the Fair Work Award increase by 4.6% and an increase in food costs of 18.6%.

With this in mind, and to ensure we continue to provide the highest quality we have carefully considered parent fees for 2023 and will be making some necessary adjustments commencing in Term One, 2023.

The new fees for BACCHUS MARSH OSHCLUB are as follows.

Before School Session	\$26.00	\$7.05
After School Session	\$30.00	\$4.50
Holiday Program	\$73.00	\$10.95

*Out of pocket price to families following max CCS rebate. Please note the Cheaper Child Care Bill will come into effect 1 July 2023 further reducing this out of pocket expense

Your family income	Child Care Subsidy percentage*
\$0 to \$72,466	85%
More than \$72,466 to below \$177,466	Between 85% and 50% The percentage goes down by 1% for every \$3,000 of income your family earns
\$177,466 to below \$256,756	50%
\$256,756 to below \$346,756	Between 50% and 20% The percentage goes down by 1% for every \$3,000 of income your family earns
\$346,756 to below \$356,756	20%
\$356,756 or more	0%

*Please note the Cheaper Child Care Bill comes into effect 1 July 2023 further reducing this out of pocket expense and lifting the lower limit from 85% to 90% and the upper ceiling limit from \$356,756 to \$530,00
